### CHAPTER 30- MONTGOMERY BILL

- VA will make monthly payments to student. VA will NOT pay students tuition. **THE STUDENT IS FULLY RESPONSIBLE FOR PAYING THEIR TUITION**
- If the tuition is not paid for, students will not be able to register for classes next semester until the bill is paid
- VA monthly payments will be based upon a student's credit hours and military time served. Time served is established by the VA

### CHAPTER 31- VOCATIONAL REHAB

- VA will pay the full SUNY Sullivan Bill

### CHAPTER 33-POST 9/11

- VA will pay student's tuition directly to SUNY Sullivan
- Student will qualify for monthly basic housing allowance if taking at least 7 credits total one of which, is taken on campus. A student cannot take all online classes
- Student will qualify for a book stipend, but will need to purchase books on their own and seek reimburse from the VA. Any Credit extension must be arranged with Bursar.

- Student is responsible for paying their own SUNY Sullivan bill

- Student is responsible for paying their own SUNY Sullivan bill

**STATEMENT OF STUDENT RESPONSIBILITIES & UNDERSTANDING FOR VETERANS BENEFITS**

- I must notify the SUNY Sullivan Veterans office within 10 business days if my address, phone or e-mail changes
- I must notify the SUNY Sullivan Veterans office within 10 business days if I change credit hours [add/drop/withdraw classes]
- I must notify the SUNY Sullivan Veterans office within 10 business days if repeating a course that I have already earned a letter grade
- I must notify the SUNY Sullivan Veterans office within 10 business days if I stop attending class
- I must notify the SUNY Sullivan veterans office within 10 business days if I change my major

All students regardless of VA benefit must certify their benefits every semester. To be certified, a student must bring a copy of their bill and class schedule to the SUNY Sullivan Veteran’s office. I further understand if I fail to comply with the above requirements, it can result in an over payment or under payment of benefits and/or may delay or stop benefits. Any overpayment becomes a debt that must be paid back to the Department of Veterans Affairs.
